CEN and CENELEC's position on the Sustainable Products Initiative

In 2020, the European Commission launched the **Sustainable Products Initiative**. At its heart is the revision of Directive 2009/125/EC on Ecodesign requirements for energy-related products to become a Regulation for Ecodesign on sustainable products (ESPR). This proposal supports the European Green Deal and fosters the transition to a more circular model that is in line with the standardization work conducted up to now in Europe.

CEN and CENELEC developed a response to the consultation launched by the European Commission on its proposal for the revision of the **Construction Products Regulation (CPR)**. In the document, the two organizations welcome the objective to achieve a well-functioning Single Market for construction products, avoid overlap of EU legislation and contribute to the EU objectives of the green and digital transition.

The German G7 presidency will host a High-level Multi-Stakeholder Conference on **"Standardization – a strategic instrument for climate action and the global digital energy transition"** on 7 September 2022 in hybrid format (Berlin and online).
