Abstract

1 Status of the project plan

2 Workshop proposer and potential Workshop participants

2.1 Workshop proposer

<u>Person (and organization) 1: Prof. Dr. Knut Blind (Technical University of Berlin and Fraunhofer Institute for Systems and Innovation Research ISI)</u>

Short description and interest in the subject:

The Fraunhofer Institute for Systems and Innovation Research ISI analyses the origins and impacts of innovations. We research the short- and long-term developments of innovation processes and the impacts of new technologies and services on society. Today, Fraunhofer ISI employs more than 400 staff members, among them scientists from the fields of natural sciences, engineering, economics and social sciences who each year work on about 400 research projects. The annual budget, more than 40 million euro in 2024, is mainly earned from contracts performed for national and international public bodies, for industry and for foundations and scientific organisations.

The primary focus of the Competence Center Policy and Society is the analysis and evaluation of research, technology and innovation policy measures, including regulation and standardisation. The prerequisite for being able to do this is profound knowledge of how national and international research and innovation systems function and their dynamics. Our scientific policy advice concentrates on analyses of the preconditions and success factors of state intervention in the innovation system; the drivers, interdependencies, developments and effects of internationalization processes (e.g. European Research Area); support instruments for innovation-oriented company start-ups, among others; the demographic dimensions of the innovation system (gender, mobility, careers), and knowledge and technology transfer processes.

The core task of the business unit "Regulation and Innovation" within the Competence Center Policy and Society is to analyse and assess regulatory framework conditions with regard to their effects on innovation. Our work provides background knowledge and impulses for designing innovation-friendly regulatory framework conditions, primarily for governmental decisionmaking bodies. However, we also deal with the self-regulation of actors in business and society, especially in the form of standardization, so that we can offer expert advice to decision-makers in business and other non-governmental organizations. Our distinguishing feature is our profound knowledge of how regulation and standardization function at national, European and international level and the dynamics involved. We consider the innovation effects of the entire quality infrastructure, which includes regulation and standardization, certification and accreditation as well as metrology. Knut Blind as head



of the business unit "Regulation and Innovation" and coordinator of EDU4Standards. EDU4Standards is a European project that strengthens education and training in the field of standardization – in line with the EU Standardization Strategy of 2022 and the Code of Practice on Standardization of 2023. Knut Blind has the responsibility to transfer the insights from the EDU4Standards project into a CWA, but also to distribute the insights among the more than 30,000 researchers active at the Fraunhofer Society and the more than 100,000 researchers organized with the European Association of Research, and Technology Organization (EARTO).

At TU Berlin, approximately more than 7, 000 staff and almost 400 professors are engaged in scientific exploration, while more than 30,000 students have the opportunity to choose from around 140 study programs. This diversity highlights the exceptional variety in teaching, research, and development opportunities, spanning from fundamental research to practical applications. Alongside the traditional engineering and natural sciences, the university's profile is also shaped by the humanities, social sciences, planning, and economics, creating an environment where technological expertise and societal responsibility complement each other. The field of Innovation Economics within the Institute for Technology and Management at the Faculty of Economics and Management was established in 2006 in collaboration with the Fraunhofer Institute for Systems and Innovation Research (ISI). Prof. Knut Blind is responsible for the business area of Innovation and Regulation and is responsible for the lecture (6 ECTS) Strategic standardisation taking place each semester.

The TU Berlin is implementing the service and development for standardization training in the European Union in its EDU4Standards project. The aim is to train the next generation of professionals for European standardization work and to build a sustainable expert base in the long term. Against this background, the objective is the development of a CEN Workshop Agreement on Standardization Training in the European Union (CEN Workshop Agreement (CWA)), which formalizes the teaching methods and content developed within the project, as well as other documents developed by the project partners.

2.2 Potential participants

This CWA will be developed in a Workshop (temporary body) that is open to any interested party. The participation of the following persons/organizations would be helpful and is desired. It is recommended that:

- Academic and research institutions involved in education, innovation, or standardization,
- University and higher education institutions (HEIs),
- National Standardization Bodies (NSBs),
- Industry stakeholders and professional associations across various sectors,
- etc

take part in the development of this CWA.

3 Workshop objectives and scope

1 Workshop background

Standardization and standards play a crucial role in the economic development of the European Union, particularly with regard to deepening the integration of the internal market. Standards are not only essential for economic growth but also central to achieving the United Nations Sustainable Development Goals (SDGs) and supporting the digital and ecological transition.



Yet, there is a significant shortage of standardization education, as only a few higher education institutions in the EU offer relevant courses. This deficit is particularly critical given the growing need for over 100,000 standardization experts – triggered by the increasing importance of standards in diverse and complex fields. While other regions of the world have already made significant progress in standardization education, the Horizon Europe EDU4Standards program is addressing this gap through a strategic, sustainable, and innovative educational approach at EU higher education institutions. The project involves leading European universities in standardization education and research, guided by the Humboldtian principle of linking academic knowledge with practical application. EDU4Standards is developing an innovative teaching concept tailored to the diverse needs of industry – including small and medium-sized enterprises (SMEs) – while simultaneously addressing the specific challenges of digital and ecological transformation. In a series of pilot projects, existing gaps in current standardization teaching will be identified and new teaching materials developed. The goal is to disseminate these new concepts and materials to EU universities – especially those that do not currently offer standardization courses. In addition, the project will encourage participation by introducing a new Education Award and increase visibility by organizing 15 "Academic Standards Days" in cooperation with national standardization bodies. The establishment of a student initiative for standardization is also planned.

The planned workshop is derived from the EDU4Standards project, funded under the Horizon Europe programme (Grant Agreement No. 101135705). The project aims to foster the integration of standardization into academic education and develops outputs that form the basis for this CWA. The CWA will provide a framework for embedding education about standardization into academic programs, supporting educators, policymakers, and institutions in aligning with best practices. It will support the development of knowledge, skills, and competences related to standardization. Future benefits include a harmonized approach to standardization education in Europe, increased engagement of academia in standardization activities, and improved integration of standardization in innovation and research projects.

5 Resource planning

The Workshop will be financed within the framework of a research project. Consortium membership and participation in the project meetings is free of charge, as the costs incurred throughout the performance of this project will be financed by funding from the Horizon Europe research project "Edu4Standards".

All costs related to the participation of interested parties in the Workshop's activities have to be borne by themselves. The copyright of the final CEN Workshop Agreement will be at CEN. The final document will include the following paragraph: "Results incorporated in this CEN Workshop Agreement received funding from the European Union's HORIZON Europe research and innovation programme under grant agreement number 101135705 (EDU4Standards).

6 Workshop structure and rules of cooperation

6.1 Participation in the Workshop

The Workshop will be constituted during the kick-off meeting. By approving this project plan, the interested parties declare their willingness to participate in the Workshop and will be formally named as Workshop participants, with the associated rights and duties. Participants at the kick-off meeting who do not approve the project plan are not given the status of a Workshop participant and are thus excluded from further decisions made during the kick-off meeting and from any other decisions regarding the Workshop.

As a rule, the request to participate in the Workshop is closed once it is constituted. The current Workshop participants shall decide whether any additional members will be accepted or not.

Any new participant in the Workshop at a later date is decided on by the participants making up the Workshop at that time. It is particularly important to consider these aspects:

- a. expansion would be conducive to shortening the duration of the Workshop or to avoiding or averting an impending delay in the planned duration of the Workshop;
- b. the expansion would not result in the Workshop taking longer to complete;
- c. the new Workshop participant would not address any new or complementary issues beyond the scope defined and approved in the project plan;
- d. the new Workshop participant would bring complementary expertise into the Workshop in order to incorporate the latest scientific findings and state-of-the-art knowledge;
- e. the new Workshop participant would actively participate in the drafting of the manuscript by submitting concrete, not abstract, proposals and contributions;
- f. the new Workshop participant would ensure wider application of the CWA.

All Workshop participants who approved the publication of the CWA or its draft will be named as authors in the European Foreword, including the organizations which they represent. All Workshop participants who did not approve the publication of the CWA will not be named in the European Foreword.

6.2 Workshop responsibilities

The Workshop Chair is responsible for content management and consensus building. The Workshop Chair is supported by the Workshop Vice-Chair (if any) and the responsible Workshop secretariat, whereby the Workshop secretariat will always remain neutral regarding the content of the CWA(s). Furthermore, the Workshop secretariat shall ensure that CEN-CENELEC's rules of procedure, rules of presentation, and the principles



governing the publication of CWA(s) have been observed. Should a Workshop Chair no longer be able to carry out her/his duties, the Workshop secretariat shall initiate the election of a new Workshop Chair. The list below covers the main tasks of the Workshop Chair. It is not intended to be exhaustive.

- Content related contact point for the Workshop
- Presides at Workshop meetings
- Ensures that the development of the CWA respects the principles and content of the adopted project plan
- Manages the consensus building process, assesses when the Workshop participants have reached agreement on the final CWA, on the basis of the comments received
- Ensures due information exchange with the Workshop secretariat
- Represents the Workshop and its results to exterior

The Workshop secretariat, provided by a CEN and/or CENELEC Member, is responsible for organizing and leading the kick-off meeting, in consultation with the Workshop proposer. Further Workshop meetings and/or web conferences shall be organized by the Workshop secretariat in consultation with the Workshop Chair. - Administrates the connection with relevant CEN or CENELEC/TCs


6.3 Decision making process

The CEN and/or CENELEC Workshop Chair is responsible for ensuring that the development of the CWA follows the principles and content of the project plan described in this document and the requirements of CEN-CENELEC Guide 29. The CEN and/or CENELEC Workshop Chair may take decisions on the conduct of the CEN and/or CENELEC Workshop on the basis of the comments expressed by the participants and of CEN-CENELEC Guide 29.

Each Workshop participant is entitled to vote and has one vote. If an organisation sends several experts to the Workshop, that organisation has only one vote, regardless of how many Workshop participants it sends. Transferring voting rights to other Workshop participants is not permitted. During voting procedures, decisions are passed by simple majority; abstentions do not count. If Workshop participants cannot be present in the meetings when the CWA or its draft is adopted, an alternative means of including them in the voting procedure shall be used.
